AUDIT STUDENTS ATTENDANCE

LCU Audit days can be used on any school day (Monday - Thursday) throughout the school year (September - May) permitting that day is not listed as restricted access on our website. Please check our website to make sure audit students are being admitted on the day you would like to attend. There is a limit of 10 audit days available per person, per school year.

LCU EXPERIENCE REFUND POLICY

LCU daily audit is \$50.00 per person, per day. LCU AUDIT STUDENT GUIDELINES

- Audit students can attend class & participate in worship and will be required to sit in the section • reserved for daily auditors unless they are an immediate family member of a current LCU student and are attending as the student's guest.
- Audit students are allowed to attend classes in the main auditorium for elective classes only.
- Audit students must not approach the stage or engage with speakers unless the speaker initiates (Calls a student out, gives a student a prophetic word, etc...).
- Audit students cannot join or attend LCU Life Groups, which happen on Mondays after the main ses-• sion, as they are a relational time for full-time students and not open to the public.
- Ministry and prayer are not guaranteed however opportunities may arise during the day.
- Audit students must be 18 years or older to attend. If you are a prospective student looking to audit • LCU at the age of 17, then you must be accompanied by a parent.
- Parents who wish to audit, please be aware that children 17 years old and under, are not allowed. (We accept mothers nursing up to 4 months old infants.)
- Our speakers and pastors normally have a full schedule during the school day and are unable to have personal meetings with audit students. For questions or prayer requests you can contact us through our website at Lifestylechristianity.com
- A LCU audit day is designed for the participant to come and encounter Jesus, receive from our speakers, and enjoy the LCU experience. We ask that audit students refrain from ministering to LCU students or staff while on campus. This means the laying on of hands, giving prophetic words, and other types of ministry. Audit student days are designed specifically for the student to come and receive what God has for them within our school environment and culture. It is our desire that audit students come to LCU with an expectation of encountering Jesus, experiencing our LCU culture and enjoying a day of receiving from God, not ministering.

Lifestyle Christianity reserves the right to ask an audit student to refrain from certain actions or behaviors. Lifestyle Christianity reserves the right to have an audit student removed from campus at any time at the security team and staff's discretion.
